

AMENDMENT #1 – Add to Constitution

ARTICLE X
DELEGATES TO NATIONAL CONVENTION

SECTION 1. The Outgoing President, the newly elected President, and the Secretary-Treasurer, by virtue of their offices shall be the first three delegates to the National Convention. The Outgoing President shall be the chairman of the delegation.

SECTION 2. If the Outgoing President does not attend the National Convention, the newly elected President shall be the chairman of the delegation.

AMENDMENT #2 – Add to Bylaws

ARTICLE II
OFFICERS AND POWERS

SECTION 9. National Executive Committeeman. The National Executive Committeewoman shall attend all meetings authorized by the National Organization. **(ADD and Renumber)**

SECTION 10. All officers and District Directors shall be elected annually, except the Secretary-Treasurer who shall be elected biennially by the Executive Committee, and the Sergeant-At-Arms who shall be appointed by the Department President to serve for one year.

SECTION 11. The retiring Department President and President elect respectively shall become by virtue of their office, National Executive Committeewoman and Alternate National Executive Committeewoman.

SECTION 12. No elective Department officer or District Director shall hold the same office for more than one year, except the Department Secretary-Treasurer, and no Department Officer shall hold two Department offices at the same time either elective or appointive.

SECTION 13. All Department Officers shall assume the duties of their respective offices at the close of the Department Convention following their election and shall serve until the close of the Department Convention of the following year, when their duly elected successors shall take office.

SECTION 14. The Executive Committee shall have power to fill vacancies occurring in the Executive Committee not otherwise provided for. Vacancies occurring in the District representation shall be filled from the same District in which the vacancy occurs.

AMENDMENT #3 – Move to Rules and Policies

ARTICLE VII
FINANCE

SECTION 1. The national per capita dues shall be ~~One Dollar and twenty-five (\$1.25)~~ ~~Two dollars and fifty cents (\$2.50)~~ per annum for Junior members and ~~Nine Dollars (\$9.00)~~ ~~Twelve dollars (\$12.00)~~ per annum for Senior members. The annual Department Dues shall be Six Dollars (\$6.00) per annum for Senior members and One Dollar and seventy-five cents (\$1.75) per annum for Junior members beginning with the per capita dues for the year ~~2013~~ 2019. The per capita dues, ~~Nine Dollars (\$9.00)~~ per annum for Senior members, shall include a subscription to the American Legion Auxiliary Magazine. **(Move to Rules and Policies)**

AMENDMENT #4 – Add New Section 1 to Article VII – Finance

SECTION 1. The National per capita dues and the annual Department dues shall be set forth in the Department Rules and Policies. **(ADD)**
