MEMBERSHIP: Nothing to report.

MINUTES: Minutes of the August 2016 meeting were read. Bruce Moran made a motion that the Minutes be approved as read; seconded by Bob Glover and unanimously approved.

TREASURERS REPORT: The Treasurer's Reports for September 2016 was read. Bob Glover reported the Post received the electric bill for \$34 and he will pay that soon. Greg d'Arbonne made a motion that the Treasurer's Report be approved as read; seconded by Bruce Moran and unanimously approved.

SICK CALL AND EMPLOYMENT:

• Bob Glover, despite attending the meeting, reported he is doing fine after his surgery but he cannot put any weight-bearing loads on that leg and hip for the next eight weeks.

OLD BUSINESS:

- Flag Deposit Box: Bill Graham sent a note to Greg d'Arbonne stating he will check with one of the employees at the Transfer Station about the box. Both Del Porter and Jim Pope reported they spoke to the Director of the Transfer Station and the box is full plus he has an additional plastic tub full of flags. Greg d'Arbonne stated one of the Boy Scouts might be willing to paint the box. It was suggested the Post consider a Flag Retirement ceremony in November because of the number of unserviceable flags we currently have in the basement. The fire risk is a concern, though, due to the drought. The members will take this up again at the October meeting.
- Greg d'Arbonne stated he has not gotten any responses so he will ask again for someone to audit the Post financial books. Pam Walked said she will speak to Janet Foster, a member of the Merrimack VFW and former Hollis VFW member, who is an accountant to see if she is willing to assist the Post.

• Jim Pope asked what we need to do to winterize the building before it gets too cold. It was suggested we speak to the Managers of Lowe's and Home Depot to see what they can do to assist with some of their employee engagement projects or to provide supplies. Porter stated the oil tank is down to ¼ full. Greg d'Arbonne made a motion that the Post have the tank filled before the end of September; seconded by Del

- Greg d'Arbonne made a motion that the Post pay the dues for Robert Knudsen who takes care of the grounds of the building; seconded by Del Porter and unanimously approved.

The meeting was suspended so the members could undrape the charter in memory of Bob Ellis who recently passed away. The meeting reconvened after the Charter was undraped.


